



Training Meeting #6 Minutes of September 17, 2008  
Schultz Center

Greg Bing, President called the meeting to order at 6:30pm. There were 79 persons in attendance.

Reading of the September 3<sup>rd</sup> meeting minutes were waived. The President asked that the New Members complete the New Member roster for the Secretary. Returning members were asked to update their information for the Arbiter and SABO Roster. The Treasurer requested that a new W-9 form be completed by all members.

The Deadline for FHSAA registration is October 1, 2008. Late registrations shall incur a \$10 late fee from the FHSAA.

All members must comply with the Provisions of the Florida Jessica Lunsford Act which provides for the completion of Background screening for all Sports officials. The President informed the membership that SABO will not to accept any dues, funds, etc., from new or returning officials without receiving Background clearance per the Florida Jessica Lunsford Act.

There is a new procedure for getting a background check for the first time. Go online to initiate Background screening for Duval County. Go to [www.duval.sofn.net](http://www.duval.sofn.net). The vendor number for Duval County is CC00233. Cost is \$73.25. It is best to get approved in Duval County, as all other Counties recognize Duval County.

**Vice-President's Report:** Girls Middle School season games will be on Tuesdays (12 Duval games) and Thursdays (12 Duval games & 4 St Johns games)

**Commissioner's Report:** The Commissioner asked that members check the Arbiter and the [www.sabo.cc](http://www.sabo.cc) Web site for news updates. The Grey and black pinstriped shirt and black shorts may be used for Duval Girls Middle School season. Officials with a Rank 1 classification for the past five years may petition the FHSAA for a testing exemption.

As was the case last year, for varsity games only, the home team wears white, and the visiting team wears dark uniforms. If either team violates, the penalty will be one direct technical assessed to the head coach.

**Directions to Creekside High School:** 100 Knights Lane St. Johns, FL 32259

Take I-95 South to 210W. Take 210W to Russell Sampson (0.1 miles past Mobil Station) Turn Right on Russell Sampson: after 1.5 miles, Liberty Pines Academy is on the Left. Stay on Russell Sampson to first traffic light, which is CR 2209(St. Johns Parkway) 2.2 miles Go thru traffic light on to Longleaf Pine Parkway (CR 244) – after 1.8 miles, Creekside High School is on your left.

From I-295 South, take San Jose Blvd (St Rd 13) south for 4.1 miles to Race Track Rd. Turn Left on to Racetrack Road; going east for 3.2miles (you'll pass Fruit Cove MS) to Veterans Parkway Turn Right on to Veterans Parkway' going South for 1.6 miles to Longleaf Parkway (CR 244) Turn Left on to Longleaf-Creekside ¼ mile on Right. Stay on longleaf across St. Johns Parkway (CR 2209) for 2.5 miles to Liberty Pines Academy

**Directions to Ponte Vedra High School:** 460 Davis Park Road Ponte Vedra, FL 32081

From I-95, Take County Rd 210 (in northern St Johns County) East  
Turn left (North) at the light on Phillips Hwy  
Turn right (East) at the first light, back on to CR 210  
Go about 6-7 miles and turn right at the Davis Park Rd light. Pass the church that is under construction on the left and continue straight on Davis Park Rd. When you can see the school, bear left  
Enter the second parking lot on the right (You will pass the gym entrance)

From A1A: Take Palm Valley Rd or Mickler Rd (West) to the Mickler Circle  
Exit the circle headed West on CR 210. Cross the bridge over the Intracoastal Waterway  
Go about 1 mile and turn left at the Davis Park Rd light. Pass the church that is under construction on the left and continue straight on Davis Park Rd. When you can see the school, bear left  
Enter the second parking lot on the right (You will pass the gym entrance)
